GENERAL CONDITIONS OF SALE

A) Terms of trade are strictly net monthly. Accounts becoming overdue may render the credit facilities liable to suspension and/or closure without notice until payment has been received by the company for all goods/services supplied by them to the purchaser under any contract in force between the company and the purchaser.

B) Property in any goods shall remain with the company.

C) The purchaser shall store any goods in such a way that they can be readily identified as being the property of the company.

D) Subject to (E) and (F) below the purchaser shall be at liberty to sell the goods in the ordinary course of business on the basis that the proceeds of such sale shall belong to the company to whom the purchaser shall account on demand provided that the purchaser shall have no authority to enter into any contract of sale on behalf of the company and any contract of sale shall accordingly be concluded in the purchaser's name.

E) The company may at any time revoke the purchaser's part of sale by notice to the purchaser if the purchaser is in default for longer than seven days in the payment of any sum whatsoever due to the company or if the company has bona fide doubts as to the solvency of the purchaser.

F) The purchaser's power of sale shall automatically cease if a receiver is appointed over any of the assets or the undertaking purchaser or if a winding up order is made against the purchaser or if the purchaser goes into voluntary liquidation (otherwise than for the purpose of reconstruction or amalgamation) or cause a meeting of or makes any arrangement or composition with creditors or commits any act of bankruptcy.

G) Upon determination of the purchaser's power of sale under (E) and (F) above the purchaser shall place the goods at the disposal of the company who shall be entitled to enter upon any premises for a purpose of removing the goods and to remove the goods.

Payment terms are Strictly 30 Days from date of invoice. Failure of payment will result in Account Facilities being put on STOP and the use of our services will no longer apply.
